Dear Customer/Supplier

SUBJECT: INFORMATION ON THE TREATMENT AND PROTECTION OF PERSONAL DATA IN ACCORDANCE WITH THE ART. 13-14 OF THE GDPR (GENERAL DATA PROTECTION REGULATION) EU 679/2016.

On May 25, 2018 the new legislation on the processing and protection of personal data came into force. According to the law, the processing of data will be based on principles of correctness, lawfulness, transparency and protection of your privacy and your rights.

Strumentazione Industriale srl (hereinafter "Controller ") informs you that, pursuant to Article 13 of the GDPR 679/2016, your data will be processed in the manner and for the following purposes.

Personal data (personal identifiers) are those identifying; they are not "particular" Personal data (former sensitive) by way of example: name, surname, social security number, VAT number, telephone number, e-mail address. Please note that your personal data are in our archives due to previous requests, orders, contacts collected during exhibitions, events, visits and opportunities for professional collaboration.

The Controller collects personal data with the sole purpose of carrying out their own activity on behalf that you conferred us. The data, supplied by you, will be recorded on protected IT supports; and the paper forms will be correctly maintained and protected by us, in accordance with the "accountability" principle expressed in the GDPR.

Your personal data are processed:

A) Without your express consent, art. 6 lett. b, paragraph 1 of the GDPR, for the following service purposes:

- fulfilment of pre-contractual, contractual, tax and tax obligations deriving from existing relations with you;
- fulfilment of the obligations established by law, by a regulation, by community legislation or by an order of the Authority;
- communications with your technical / commercial staff in relation to potential or actual supplies of materials;
- drafting of commercial offers both in paper form and by e-mail;
- exercise of the rights of the Controller, for example the right of defense in court;

B) Except for your dissent art. 7 GDPR for the following marketing purposes:

- technical updates related to the treated products;
- technical / commercial communications on products or services offered by the Controller;
- reporting of events or free invitations to participate in trade fairs;

The provision of data for the purposes referred to in point A) is mandatory. The failure, partial or incorrect conferment, will not allow us to guarantee the performance of the services of point A), precluding STRUMENTAZIONE INDUSTRIALE SRL to fulfil the contractual obligations.

The provision of data for the purposes referred to in point B) is optional. You can therefore decide not to give any data or to subsequently deny the possibility of processing data already provided: in this case you will not be able to receive the services offered by the Controller at point B).

Without your express consent, the Controller may communicate your data for the purposes referred to in point A) to Supervisory Bodies, judicial authorities, as well as to all other subjects to whom the communication is mandatory by law for the accomplishment of the said purposes. . Your data will not be disclosed.

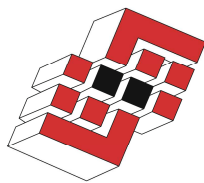

Your data may be made accessible for the mentioned above purposes:

- to employees and collaborators of STRUMENTAZIONE INDUSTRIALE SRL, in their role as internal person in charge of and persons in charge of processing personal data and / or system administrators
- to third parties (such as credit institutions, professional offices, etc.) who carry out outsourcing activities on behalf of the Controller, in their capacity as external responsible of the processing

The treatment will be carried out with manual and / or computerized and telematic tools with organizational and processing logics strictly related to the purposes themselves and in any case in such a way as to guarantee the security, integrity and confidentiality of the data in compliance with organizational and physical measures and logics provided for by the provisions in force. Personal data is kept for the entire duration of the report, unless otherwise agreed, on your express statement.

You can, at any time, exercise the rights provided for in Articles 15 to 21 GDPR:

- access to your personal data;
- to obtain the correction, the integration or the cancellation of the same or the limitation of the treatment that concern them;
- opposition to the treatment;
- right to the portability of data;
- to revoke the consent, where foreseen: the revocation of the consent does not affect the lawfulness of the treatment based on the consent given before the revocation;
- to propose a complaint to the supervisory authority (Privacy Guarantor or Judicial Authority).
